With support for current and future regulations and regulatory reporting requirements, Fusion Invest offers simpler risk control and decision-making.

Portfolio managers have a complete, 360-degree view of the business, giving them the ability to collaborate more and make better decisions



Portfolio monitoring

From a single portfolio view, Fusion Invest models insurance portfolios (life and non-life), segregated accounts, mandates, pension funds and unit linked portfolios. It relies on a flexible portfolio tree structure to easily view and analyze managed asset holdings, both internally and externally. Fusion Invest can handle single and multiple portfolio analysis across currencies and asset classes with easy distinction of asset categories.

Accounting metrics

Fusion Invest replicates in real time an estimate of the P&L figures similar to that generated by the accounting system, allowing the portfolio manager to make informed decisions immediately. The solution provides a regular reconciliation and realignment with the accounting system via an import that becomes the new baseline for computation.

Solvency II capital requirement

Relying on its transparent pricing and analytics engine, Fusion Invest can compute the SCR/MCR components (Solvency Capital Requirement and Minimum Capital Requirement) of the market risk module, allowing the portfolio manager to closely control the effects of investment decisions on each module of the market SCR. Fusion Invest also takes into account C-ROSS and other worldwide capital-based regulatory constraints.

These capabilities are also supported by market data such as the regulatory risk-free discount curves, built according to EIOPA's recommendations with liquid market swaps or bonds and interpolated/extrapolated using a Smith-Wilson methodology.

The model is fully flexible and evolutionary, allowing asset managers to customize the level of the main parameters, such as the UFR rate, convergence speed, tolerance, credit and volatility adjustments.

Investment decision support

In addition to providing accounting P&L figures and solvency capital requirements, Fusion Invest helps portfolio managers to reach their P&L targets while monitoring their capital consumption. By providing pre-trade accounting and risk indicators, the solution offers the ability to simulate orders and compute their simulated effects at all levels, from the whole accounting book to the tax lot level.

Yield projection

Monitor the accounting yield and duration of the portfolio and its projection over the coming years by anticipating the portfolio's future reinvestment yield and duration. This projection is built from the accounting P&L figures, duration and cash flows of the portfolio computed by Fusion Invest.

Portfolio optimization

Fusion Invest's optimization plugin, combined with its pre-trade simulation workflow, enables portfolio managers to optimize their portfolio according to several dimensions, for example solvency requirements, constraints on taxes and realized P&L under different accounting rules, or their own business constraints and views on the market forecast.

Future-proof technology

Using Open APIs, Fusion Invest offers access to fintechs and ability to interface with third parties for portfolio management and order raising. As insurance asset managers look for more agility and cost optimization, Fusion Invest can be deployed on private and public clouds.
